

## **KELLANOVA™ SHELF CARE SWEEPSTAKES**

### **OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. INTERNET ACCESS REQUIRED. VOID WHERE PROHIBITED.

1. PROMOTION DESCRIPTION. The **Kellanova™ Shelf Care Sweepstakes** (the “**Sweepstakes**”) is an online entry only Sweepstakes that begins on 1/1/26 at 12:00:00 AM Eastern Time (“**ET**”) and ends on 6/30/26 at 11:59:59 PM (ET) (the “**Promotion Period**”). For purposes of this Sweepstakes, a “day” is defined as any 24-hour period beginning at 12:00:00 AM (ET) and ending at 11:59:59 PM (ET).

The Promotion Period consists of six (6) monthly entry periods (each, a “**Monthly Entry Period**” and collectively, the “**Monthly Entry Periods**”) wherein “**Monthly Prizes**” (as defined below) will be awarded at the conclusion of each Monthly Entry Period from among all eligible entries received as of the end of the corresponding Monthly Entry Period, as described herein. Monthly Entry Periods begin on the first day of each calendar month during the Sweepstakes Period at 12:00:00 AM (ET) and ends on the last day of the corresponding calendar month at 11:59:59 PM (ET).

2. ELIGIBILITY. Open to legal United States residents residing in the fifty (50) United States and District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees, officers, and directors of Kellanova (“**Sponsor**”), its parent company, affiliates, subsidiaries, partners, advertising, promotion and other agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply.
3. HOW TO ENTER. During the Promotion Period, look for Sweepstakes displays that will include a QR Code at participating foodservice facilities. Scan the QR code with your web-enabled mobile device or go directly to [www.shelf-care.com](http://www.shelf-care.com) (“**Website**”) and then follow the instructions at the Website to complete the online registration form and enter the Sweepstakes. Limit up to one (1) entry per person/email address, per day for the Sweepstakes. All entries become the property of Sponsor and will not be returned. Online entries must be completed by 11:59:59 PM (ET) on 6/30/26.

No automated entry devices, bots and/or other programs and/or software are permitted for entry. Sponsor is not responsible for lost, late, illegible, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind, whether mechanical, human or electronic. Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. Promotion Entities assume no responsibility or liability for any error,

omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries. Only fully completed entries are eligible.

Use of any automated system to participate is prohibited and will result in disqualification. All potential winning entries are subject to verification by Sponsor, whose decisions are final and binding. Any entry that occurs after the system has failed for any reason is deemed a defective entry and is void and will not be honored.

Sponsor is not responsible for any change of mailing address, email address and/or telephone number of entrants. In the event of a dispute over the identity of an online entrant in the Sweepstakes, participation will be deemed completed by the authorized account holder of the email address provided at the time of participation. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider, wireless carrier, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. The potential winner may be required to provide Sponsor with proof that he/she is the authorized account holder of the email address account associated with the winning entry. If a dispute cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

RANDOM DRAWING: Forty (40) potential prize winners for each Monthly Entry Period will be selected in a random drawing to be conducted on or about the 7<sup>th</sup> of each month following a Monthly Entry Period from among all eligible entries received for the respective Monthly Entry Period by Sponsor or its designee. The decisions of the Sponsor are final and binding. Non-winning Monthly Entries will automatically rollover to any subsequent Monthly Entry Period(s).
5. WINNER NOTIFICATION: Potential prize winners will be notified by email, using contact information provided or collected at time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited and an alternate prize winner may be selected.
